**Open Limited\* Gun Dog:** \$50.00 Entry Fee, 30 Minute Horseback Stake, beginning no earlier than 10:00 am on Thursday, November 26, 2009.  
**Open Derby:** \$40.00 Entry Fee, 20 Minute Horseback Stake, to follow Open Limited Gun Dog.  
**Open Gun Dog:** \$50.00 Entry Fee, 30 Minute Walking Stake, Retrieving, to follow Open Derby.  
**Amateur Limited\* Gun Dog:** \$50.00 Entry Fee, 30 Minute Walking Stake, to follow Open Gun Dog.  
**Amateur Gun Dog:** \$50.00 Entry Fee, 30 Minute Walking Stake, Retrieving, Vizsla Only, not before 7:00 am November 29, 2009.

**Course B**

**Amateur Walking Derby:** \$40.00 Entry Fee, 20 Minute Walking Stake, Vizsla Only, not before 7:00 am November 28, 2009.  
**Open Puppy:** \$35.00 Entry Fee, 15 Minute Walking Stake to follow Open Gun Dog  
 \* Entered dogs must have received a field trial placement in a Gun Dog stake or placed first in an Open Derby stake at an AKC licensed field trial prior to November 26, 2009.

All stakes shall be held in compliance with all applicable **AKC Field Trial Rules and Standard Procedures for Pointing Breeds**. Handling from horseback is permitted in the Open Limited Gun Dog and Open Derby stakes only. Retrieving stakes will have a call-back for the retrieve. Blanks are to be fired in all stakes (.22 caliber crimps are not allowed).  
 AKC approved tracking collars are permitted. Tracking collars may not be used during the call-back for retrieve.
