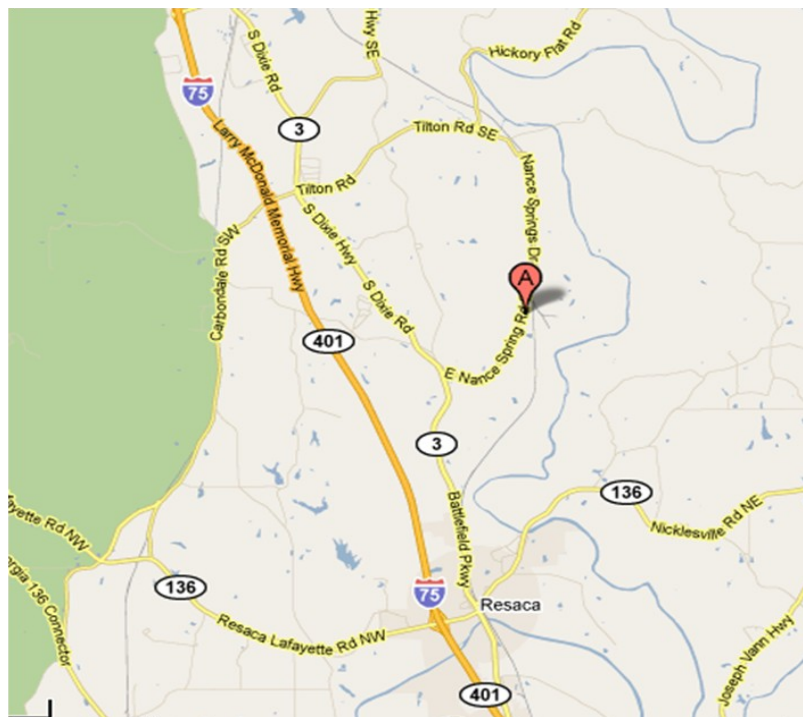

**SINCE THE USE OF FIREARMS IS INHERENTLY DANGEROUS, WE REQUIRE ALL SHOOTERS AND FISHERMEN TO ASSUME ALL RISKS BY SIGNING AND ACKNOWLEDGING THIS RELEASE AND WAIVER.**

**I, Guest**, hereby acknowledge that I have voluntarily requested to participate in sporting clays, quail and/or pheasant hunting, fishing, and other similar connected sporting activities on property owned or leased by SILVER SHOE RANCH, LLC (the Ranch). **AS CONSIDERATION** of being permitted to enter upon the premises upon which the activities are conducted and of being permitted to participate in or observe activities or otherwise use the facilities of the Ranch, I, the undersigned, on behalf of myself, my heirs and assigns to the provisions set forth below.

I hereby release, waive, discharge and covenant not to sue, make a claim against the person or persons or property of or otherwise prosecute the Ranch, or any affiliate organization, officers, directors, members, agents and/or employees (hereinafter collectively referred to herein as "Releasee"), for any loss, cost or liability on account of damage to the property of, or injury to, the person or death of the undersigned, whether caused from the passive or active negligence of Releasee or otherwise while the undersigned is participating in or observing the shooting, hunting or fishing related activities being provided by Releasee.

I hereby agree to indemnify and hold Releasee harmless from and against any loss, liability, damage, or cost the Releasee may incur due to the presence of or any act of the Undersigned while the Undersigned participates in or observes shooting, hunting, fishing and related activities being provided by Releasee, whether caused by the passive or active negligence of Releasee.

The Undersigned expressly agrees that the within and foregoing Release, Waiver and Indemnity Agreement is intended to be as broad as is permitted by the laws of the State of Georgia. The Undersigned further agrees that if any provisions of this Agreement are held to be invalid, nevertheless the balance of the agreement shall continue in full force and effect.

The Undersigned warrants that the following statements are the true and correct and understands that Releasee has relied on them in entering into the foregoing Agreement and is giving the Undersigned permission to participate in and/or observing the shooting, hunting, fishing and related activities being provided by Releasee.

The Undersigned agrees that in the event he or she damages any of the property owned or leased by the Ranch, the Undersigned will pay as damages to the Ranch the fair market value thereof as of the date of damage or loss, including, without limitation the value of any dog, vehicle or other asset.

THE UNDERSIGNED AGREES TO COMPENSATE OR REIMBURSE RELEASEE FOR ANY COSTS, EXPENSES OR DAMAGES, INCLUDING ATTORNEY FEES, RESULTING FROM ANY CLAIM BROUGHT AGAINST RELEASEE FOR PROPERTY DAMAGE, PERSONAL INJURY OR DEATH, WHICH ARISE AS A RESULT OF THE PASSIVE OR ACTIVE NEGLIGENCE OR OTHER ACT OF THE UNDERSIGNED WHILE PARTICIPATING IN OR OBSERVING THE ACTIVITIES WHILE ON THE RANCH PREMISES.
