#### STAKES, ENTRY FEES, AND SCHEDULE

**Open Limited\* Gun Dog (Horseback):** \$50.00 Entry Fee, 30-Minute Horseback Stake, beginning no earlier than 7:00 am on Thursday, November 24, 2011.

**Open Derby (Horseback):** \$40.00 Entry Fee, 20-Minute Horseback Stake, to follow Open Limited Gun Dog.

**Open Gun Dog—Retrieving (Walking):** \$50.00 Entry Fee, to follow Open Limited Gun Dog.

**Open Puppy (Walking):** \$35.00 Entry Fee, 15-Minute Stake, to follow Open Limited Gun Dog.

**Amateur Limited\* Gun Dog -Retrieving (Walking) -Vizsla Only:** \$50.00 Entry Fee, Vizsla Only, to follow Open Limited Gun Dog.

**Amateur Walking Derby –Vizsla Only:** \$40.00 Entry Fee, 20-Minute Stake, Vizsla Only, to follow Open Limited Gun Dog.

**Amateur Gun Dog (Walking):** \$50.00 Entry Fee, to follow Open Limited Gun Dog.

**Amateur Walking Puppy:** \$35.00 Entry Fee, 15-Minute Stake, to follow Open Limited Gun Dog.

\* Entered dogs must have received a field trial placement in a Gun Dog stake or placed first in an Open Derby stake at an AKC licensed field trial prior to November 21, 2011.

#### BITCHES IN SEASON MAY NOT COMPETE

All stakes shall be held in compliance with all applicable **AKC Field Trial Rules and Standard Procedures for Pointing Breeds**. Handling from horseback is permitted in the Open Limited Gun Dog and Open Derby stakes only. Retrieving stakes will have a call-back for the retrieve. Blanks are to be fired in all stakes (.22 caliber crimps are not allowed). AKC approved tracking collars are permitted. **This trial will be run under the flexible format and reserves the right to change the running order, order of the stakes, and/or run additional courses if deemed necessary to complete the trial on time.**

## LIMITED ENTRY

Entry fees should be mailed with each entry form submitted. Entries are limited to the number of dogs which can run during daylight hours. Entries will close when the limit is reached if this occurs prior to the closing date and time.

**Fax, email, and hand-delivered entries may be accepted.**

## SCRATCH POLICY

Full refund will be made prior to the drawings. After the drawings are held, only bitches in season, injury, illness, or death with a veterinarian's statement shall receive a full refund.

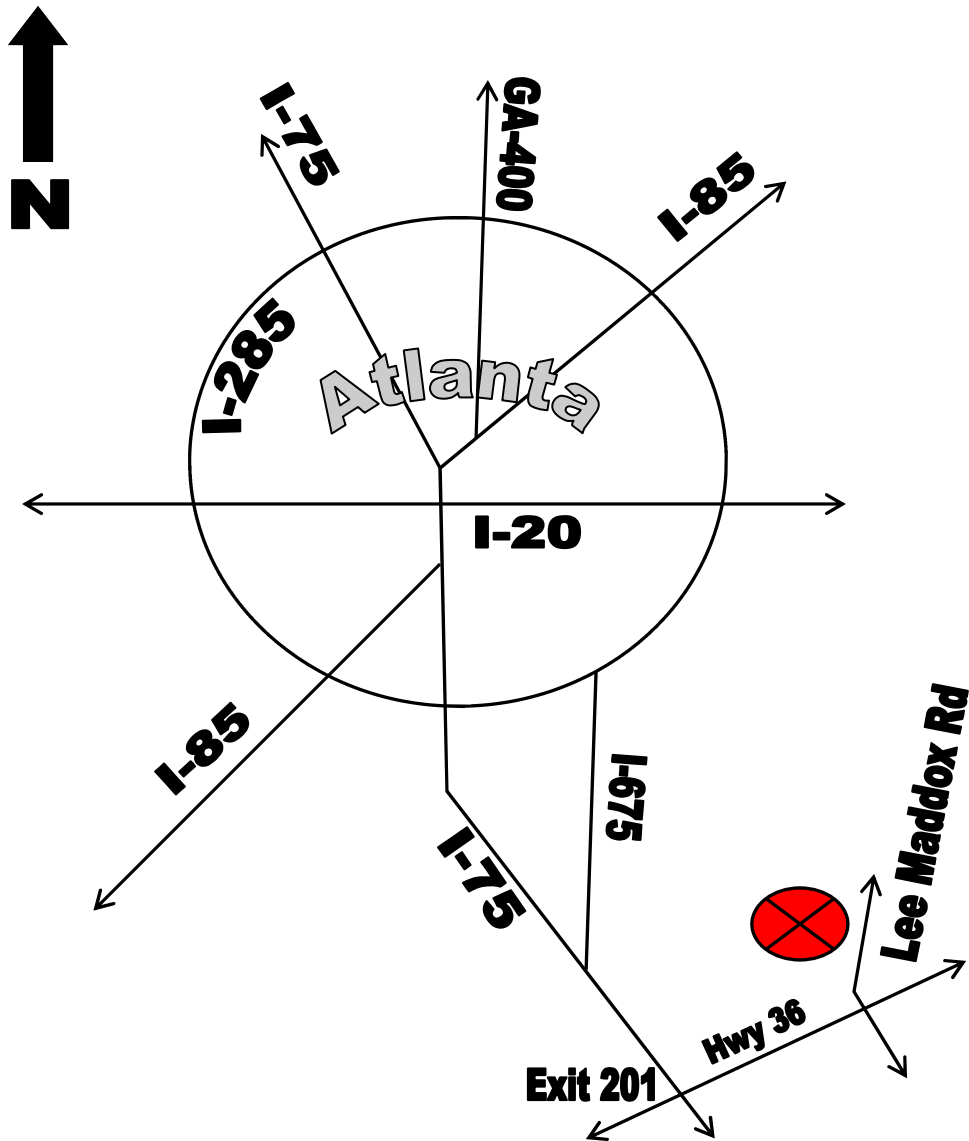
