HUNTING DOG STAKE**

The Hunting Dog Stake is a non-regular walking class open to all pointing breeds. This stake is designed to focus on dogs that have completed their JH title and are working towards the SH title. Each brace is 15 minutes. Dogs may be collared while on point and may run with a check cord.

**Eligibility:**

Any dog that is eligible to compete in licensed AKC pointing breed field trials or hunt tests is eligible to run in Hunting Dog Stakes. An award will be given to the dog that the gunners would most like to take hunting.

Any dog may run, but is not eligible for the award if it:

- Has completed a SH or MH title
- Has placed 1st in a broke dog stake

Bitches in season may not compete.

Advanced entries are \$15.00 and must be received before the hunt test closing date.

Entries may be made at the event for \$20.00.

Precedence in the running order will be given to advance entries.
